**THE ASSAM COLLEGE EMPLOYEES (PROVINCIALISATION)**

**(AMENDMENT) ACT, 2010**

further to amend the Assam College Employees (Provincialisation) Act, 2005.

Whereas it is expedient to amend the Assam College Employees (Provincialisation) Act, 2005, hereinafter called as the principal Act, in the manner, herein after appearing;

Assam Act  
No. XLVI  
of 2005

It is hereby enacted in the Sixty-first Year of the Republic of India as follows:-

Short title,  
extent and  
commencement

1. (1) This Act may be called The Assam College Employees (Provincialisation) (Amendment) Act, 2010.
- (2) It shall have the like extent as the principal Act.
- (3) It shall come into force at once.

Amendment of  
section 3

2. In the principal Act, in section 3, in clause (a), after the word "applicable" appearing at the end, the words "to the extent of their applicability is not contradictory to the provisions of this Act and the rules made there under" shall be inserted.

Amendment of  
section 6

3. In the principal Act, in section 6, the punctuation mark "." appearing at the end, shall be substituted by the punctuation mark ":" and there-after the following proviso shall be inserted, namely:-

"Provided that some of the powers of the Appointing Authority may, however, be delegated to the Governing Body of the colleges as may be provided in the rules."

Insertion of  
section 8A

4. In the principal Act, after section 8, the following new section 8A shall be inserted, namely:-

"Extension of  
time for refund  
of the  
Government's  
share of  
Contributory  
Provident Fund

- 8A. Notwithstanding anything contained in the provisos to section 8, the period of six months, within which the Government's share of the Contributory Provident Fund was required to be refunded in respect of the retired /deceased employees under the first proviso to section 8, shall be further extended upto a period of six months from the date of coming into force of the Assam College Employees (Provincialisation) (Amendment) Act, 2010, and the intervening period from the date of expiry of the original period of six months under the first proviso to section 8 till the date of coming into force of this Amendment Act, shall also be deemed to have been extended for the purposes of section 8."
