

c) The Parties, therefore, agree on the objective of creating a framework for enriching scientific endeavors in mutual academics, research, and industrial training.


EFFECTIVE DATE AND DURATION OF MOU

This MOU takes effect from the date of signing by both the parties and initially will continue for a period of 5 years. Prior to the expiry of this MOU, the parties may agree in writing to extend or curtail the period.

ROLE OF SIBIN

- d) Will help in bringing eminent industry leaders and sector related academia.
- e) Will facilitate in organizing trade related workshops/ Seminars/Conferences and Trade fairs.
- f) Undertaking capacity development initiatives for PRAGJYOTISH COLLEGE.
- g) Sourcing live projects for the students from corporations in the sector.
- h) Other related initiatives with an objective of making the vocational and industrial courses industry-oriented.

- a. Notwithstanding the non-binding nature of this Memorandum, the Parties will act in good faith and will use their best endeavours to achieve the purpose and give effect to the terms of this MOU.

- c. Both parties agree to cooperate in the spirit of mutual understanding and goodwill in order to develop the parties relationships with one another and in order to pursue the purpose.
- d. Use of name and logo: Both parties will use the name or logo of the other party for publicity, advertising, or news release only after written approval of the other party.


