YUVAAN EDUCATIVE LLP, a company incorporated under the Limited Liability Partnership Act, 2008, having its registered office at Opposite Goswami Service, Near Hotel Paradise, GNB Road, Guwahati - 781003, which expression shall, unless repugnant to the context or meaning thereof, be deemed to include its successors and permitted assigns of the FIRST PART;

-AND-

PRAGJYOTISH COLLEGE, Accredited by NAAC since 2004 (3rd Cycle), Recognised under sections 2(f) and 12(B) of UGC, Affiliated to Gauhati University, which expression shall, unless repugnant to the context or meaning thereof, be deemed to include its successors and permitted assigns of the SECOND PART;

WHEREAS:

- A. **YUVAAN EDUCATIVE LLP** is engaged in imparting National Skills Qualification Framework (NSQF) aligned skill development courses in various trades including Retail Management, Tourism & Hospitality, Beauty & Wellness, IT/ITes, Electronics & Hardware, Agriculture & Horticulture, Private Security, Healthcare, Agriculture (Dairy Farming), Automotive, and Apparels. The organization has a team size of more than 1000 people and constantly recruits professionals who are expert in relevant trades in the capacity of Vocational Trainer/Service Provider.
- B. **PRAGJYOTISH COLLEGE** has already been honouring graduation/post graduation degrees in relevant subjects such as Agriculture, Marketing, Tourism, IT etc that makes it's students and pass pupils eligible for the role of Vocational Trainer In Yuvaan Educative's Vocational Education Department.

NOW, THEREFORE, in consideration of the mutual representations, warranties and covenants contained herein, and for good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, the Parties hereto agree as follows:

1. **YUVAAN EDUCATIVE LLP** agrees to continue offering placement opportunities to final year (appeared) and pass pupils/students for diverse roles in it's organization. It may be noted that Yuvaan Educative LLP has already been absorbing students/pass-pupils from the university at regular intervals since 2017.
